



# RECREATION AND PLAY VOUCHER PROGRAM

## GET YOUR RECREATIONAL FEES AND EQUIPMENT COVERED

Participating in sports and other recreational activities is an essential part of any healthy community. The Recreation and Play Voucher Program aims to increase the number of individuals participating in organized sports or other recreation activities by reducing cost as a barrier. Organizations, participants, parents, caregivers, coaches, teachers, or guardians can apply for a voucher which can be used towards sport and active recreation equipment, membership, registration, or participation fees.

Vouchers are issued on a first come, first serve basis, with the potential for funding to be renewed as continued need is expressed.

## ELIGIBILITY

### MEMBERSHIP, REGISTRATION, OR PARTICIPATION FEE VOUCHERS

- Any individual who desires to participate in an organized sport or recreation activity that is provided by a recreation department, school district, or non-profit sports or recreation organization.
- Any individual who is experiencing a financial barrier to participation caused directly or indirectly by the Camp Fire, or otherwise cannot afford to participate.
- The program is available to residents of Butte and Glenn Counties for participation in programs that are offered within the boundaries of Butte and Glenn Counties.
- Any individual who has not received a membership, registration, or participation voucher at any time during the previous calendar year.
- The voucher request may not exceed **\$250 per participant**.
- Applications must be submitted by case managers or a recreation department, school district, or non-profits sports or rec department on behalf of the individual.

### RECREATION EQUIPMENT VOUCHERS

- Any individual who desires to participate in an individual sport or recreation activity.
- Any individual who is experiencing a financial barrier to participation caused directly or indirectly by the Camp Fire, or otherwise cannot afford to participate.
- Any individual who has not received an equipment voucher at any time during the previous calendar year.
- Applications must be submitted by case managers or a recreation department, school district, or non-profit sports or recreation organization on behalf of individuals who will receive the voucher.
- The voucher request may not exceed **\$150**.
- Applications must be submitted by case managers or a recreation department, school district, or non-profits sports or rec department on behalf of the individual.

# HOW TO APPLY



## VOUCHERS FOR MEMBERSHIP, REGISTRATION, OR PARTICIPATION FEES

- The voucher request may not exceed **\$250 per participant**.
- **IMPORTANT:** Applications must be submitted by case managers or a recreation department, school district, or non-profits sports or rec department on behalf of the individual. Funds for membership, registration, or participation fees will be disbursed only to organizations on behalf of the participant, not directly to participants.

**What is the Recreation and Play Voucher Program?**

The purpose of the **Recreation and Play Voucher Program** is to increase the number of individuals participating in organized sport or other recreation activities by reducing cost as a barrier. The program is administered by **Everybody, Healthy Body** with funding provided by the **North Valley Community Foundation**. Organizations, participants, parents, caregivers, coaches, teachers, or guardians can apply for a voucher which can be used towards sport and active recreation equipment, membership, registration, or participation fees.

**How long will the program be available?**

Vouchers are issued on a ‘first come, first served’ basis, with the potential for funding to be renewed as continued need is expressed.

Applications for vouchers will be submitted online, and the applicant will be notified of the status of their voucher within 14 days of submission.
